4.0 The following are the activities of IIM Delhi Chapter for 2024-25:

- 12 EC meetings of IIM DC were held in 2024-25. Various issues relating to IIM Delhi Chapter including organising the flagship event of the Chapter i.e. MMMM 2024 and IMMS 2025 Summit were discussed in the meetings.
- Interaction was held with IIT Delhi to promote the IIM membership. Eight new members were enrolled during 2024-25. Out of these eight members, six are life members and two ordinary members. Now the total number of members of our Chapter is around 330.
- As per specific request, some members visited M/s Yogiji Digi Works at Faridabad (Haryana) on 8.11.2024.
- Audited accounts of the Chapter for 2023-24 were sent to Head Office in May 2024.
- Half yearly accounts of our Chapter for six months ending September 2024 were also audited and sent to Head Office on 16.1.2025.
- IIM Delhi Chapter representatives participated in the CRC meetings convened by Head Office in July 2024 and November 2024.
- Office bearers participated in all the National Council Meetings, AGM and EGM of IIM

- The website of IIM Delhi Chapter is being regularly updated. Details of all technical activities, publications of IIM Delhi chapter are being regularly posted on our Chapter's website.
- Several meetings were held with HYVE to discuss the terms and conditions of our association with them for MMMM 2024 event held at New Delhi from 27th to 29th September 2024.
- Several meetings were held with DIIA Event Solutions to discuss about the preparation of IMMS 2025 Summit which was held on 28.2.2025.
- MMMM 2024 was organised at Yashobhoomi, New Delhi from 27th to 29th September 2024. The Theme of the Conference was "Process and Product Innovations in Metal Production". About 150 persons participated in the Conference.
- IMMS 2025 Summit was held at IIC on 28.2.2025. The Theme of the Summit was "Smart Metallurgy: Digital Transformations and Automation". About 70 persons participated in the Summit.
- A monthly newsletter named as "Met-Info" is being published and mailed to IIM Delhi Chapter members. Soft copies of the Met-Info are also being posted on IIM-DC website regularly. The contents of the Newsletter are receiving good response and appreciation from some members.
- Symposium was held by IIT Delhi on 26th and 27th April 2025. IIM Delhi Chapter was Co-Organiser of the Symposium. The Topic of Symposium was AI/ML and Multiscale Modelling for Materials Discovery. About 80 participants attended the Symposium.
- Infrastructure of Delhi Chapter was upgraded. Two new ACs were purchased in April 2024 for our Board Room as the existing AC's of Board Room were more than 15 years old and were not functioning properly.
- Valuation of IIM DC fixed assets was got done by a registered valuer and sent to IIM Head Office.
- Various cost reduction measures were taken during the year, so as to maintain the cash flow of the Chapter positive.

IIM DC has about 750 books and journals in the library.
